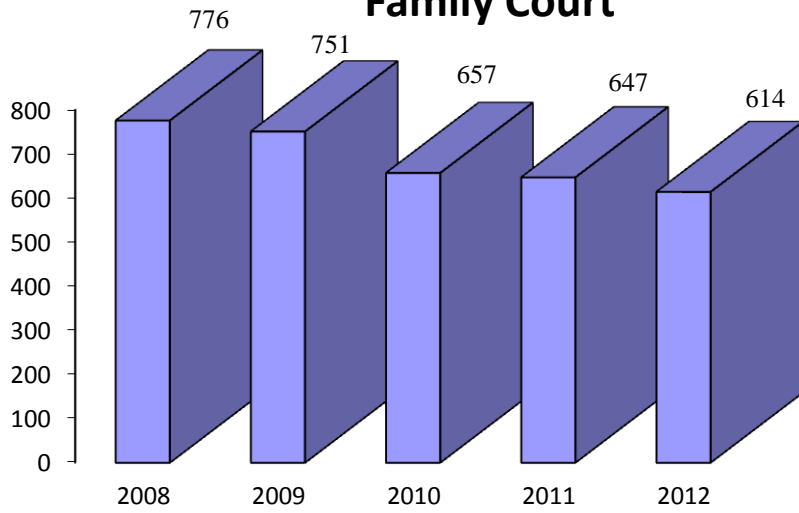

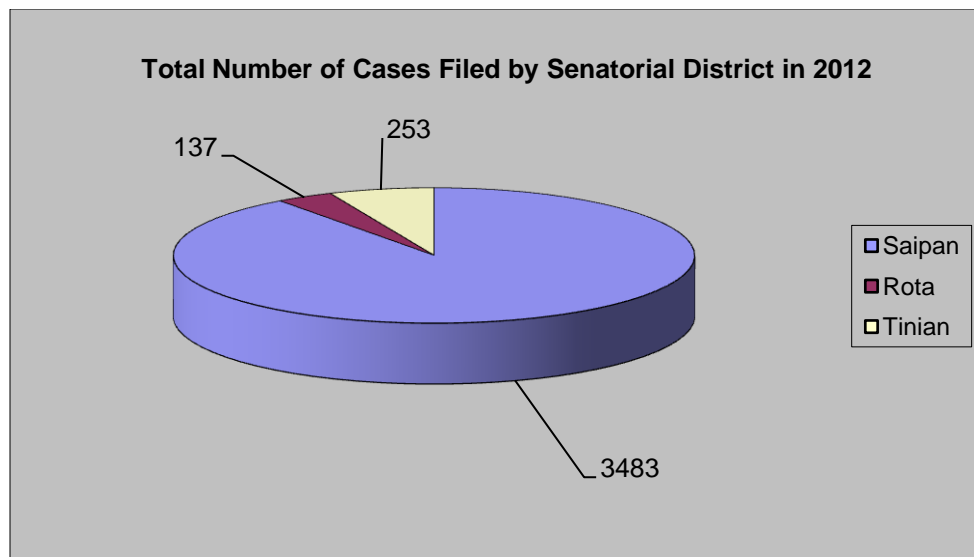
Statistics show an active incline/decline in filings for all caseloads in the last five (5) years. Specific figures are provided in the activity report.
